

Rules and Instructions

How to Play

- · There is no limit to the number of people who can participate in the Pipetting Challenge.
- · Minimum of ten (10) participants are required for a lab to qualify for the Team Prize.
- Using a 20 µL volume pipette and your Artel PCS® Pipette Calibration System, take 10 consecutive data points with no deleted points. If you don't own a PCS, call Artel for details on obtaining a loaner; only data points taken using the PCS are eligible for the competition.
- The data must be taken and dated within the enrollment time frame April 24-30, 2022, and must be signed by the participant and a supervisor or other unrelated party.
- Submit your scores online at https://www.artel.co/team-scores-submission/ and email a scanned copy of the original
 paper printout from the PCS or Artel PCS Software™ report. Data submissions must be received electronically by May 15,
 2022, in order to be eligible for the competition.
- · Limit one entry per person. Artel is not responsible for stolen, lost, late, misdirected, damaged, undeliverable, incomplete, or illegible entries.
- In order to obtain your best results, review the Manual Pipetting Best Practices wall poster. Make sure you get plenty of practice.

Team Prizes

The labs with the three lowest average CV's for all their participants will win Team Prizes.

- 1. Team Gold \$300 gift card toward lab luncheon
- 2. Team Silver \$200 gift card toward lab luncheon
- 3. Team Bronze \$100 gift card toward lab luncheon

Individual Awards

If your individual CV score falls within Artel's proficiency guidelines you will be awarded a Gold, Silver or Bronze Pipetting Challenge medal according to the following:

Gold: 0.00 - 0.19% CV Silver: 0.20 - 0.49% CV Bronze: 0.50 - 1.00% CV

Eligibility
